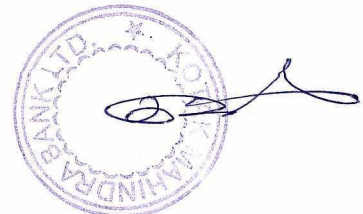
**Sub: Notice for Sale of the Mortgaged Property**

1. We refer to Demand Notice dated 26.03.2021 issued by Fullerton India Home Finance Company Ltd (hereinafter referred to as "FIHFCL") under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. 603607210478648 wherein FIHFCL had called upon you to pay the dues of **Rs. 36,22,447.40/- (Rupees Thirty Six Lakh Twenty Two Thousand Four Hundred Forty Seven And Forty Paise Only)** due and payable as on 25.03.2021 along with future interest applicable from 26.03.2021 until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by FIHFCL within 60 days from the date of the said Notice. You have since then failed and neglected to pay the amount as demanded.
2. FIHFCL has vide an assignment agreement dated 28.03.2023 ("Assignment Agreement") has assigned the debts due and payable by you in favour of Kotak Mahindra Bank Limited (hereinafter referred to as "KMBL/The Bank") along with all its rights, title, interests, benefits in the facilities granted by FIHFCL with other incidental right thereto including the assignment of the said facilities along with the underlying securities. As per the said assignment agreement, the Bank has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part there of including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. The Bank has been subrogated in place of FIHFCL and all right, title and interest of FIHFCL in respect of Outstanding Amount is now vested with The Bank.
3. It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such, the Authorized officer of FIHFCL has taken physical possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on **12.09.2022** in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9 and in pursuance of order dated 27.06.2022 passed by Hon'ble Chief Judicial Magistrate, Chengalpat, under Section 14 of the said SARFAESI Act.

4.
