**Sub: Notice for Sale of the Mortgaged Property**

1. We refer to Demand Notice dated **15.02.2020** issued by **Kotak Mahindra Bank Limited (hereinafter referred to as "KMBL/The Bank")** under Section 13(2) of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 (hereinafter referred to as "SARFAESI Act"), related to Loan Account No. **PR00437758 & PR00429206** wherein we had called upon you to pay the dues of of **Rs. 27,10,686.73/- (Rupees Twenty Seven Lakh Ten Thousand Six Hundred Eighty Six And Paise Seventy Three Only)** (more particularly described in annexure-A herein) due and payable as of **15.02.2020** with further applicable interest from **16.02.2020** until payment in full (hereinafter referred as the "Outstanding Amount") and payable by you all under the facilities granted by **Karvy Financial Services Ltd. (KFSL)** within 60 days from the date of the said Notice. You have since then failed and neglected to pay the amount as demanded.
2. Thereafter, KFSL has transferred its entire business in favor of Mape Finserve Pvt. Ltd. (MFPL), subsequently known as Small Business Fincredit India Pvt. Ltd. (**SBFC**) vide Business Transfer Agreement dated 01.08.2017. SBFC has vide an assignment agreement dated **14.03.2019** ("**Assignment Agreement**") has assigned the debts due and payable by you in favour of KMBL along with all its rights, title, interests, benefits in the facilities granted by SBFC with other incidental right thereto including the assignment of the said facilities along with the underlying securities. As per the said assignment agreement, KMBL has become full and absolute owner and as such is legally entitled to receive the repayment of the financial facility or any part thereof including the right to file suits, institute such other proceedings in its own name and to take such other action as may be required for the purpose of the recovery of the said financial facility. The Bank has been subrogated in place of SBFC and all right, title and interest of SBFC in respect of Outstanding Amount is now vested with the Bank.
3. It is pertinent to note that despite the service of the above mentioned notice, you have failed to liquidate the outstanding dues and as such, the Authorised officer of the Bank has taken physical possession of the property described herein below in Annexure "A" (and referred hereinafter as "Secured Asset") on 23.06.2023 in exercise of the powers conferred on him under Section 13 (4) of the said Act read with Rules 8 & 9 and in pursuance of order dated 23.12.2022, passed by Hon'ble District Magistrate, Kolhapur under Section 14 of the said SARFAESI Act.
4. After taking possession of the secured asset, inspection was carried out by approved valuer in compliance of Rule 8(5) of the Security Interest (Enforcement) Rules, 2002 and on the basis of report of valuer, auction of Secured Asset as mentioned in Annexure "A" was conducted on various occasions

and lastly on 28.02.2024 with the Reserve Price of Rs. 27,00,000/- (Rupees Twenty Seven Lakh Only). However, they all failed for want of bidders.

5. Hence, for recovering its legal dues, the Bank now proposed to again invite tender/conduct public auction after fixing the reserve price and accordingly has now fixed reserve price at Rs. 27,00,000/- (Rupees Twenty Seven Lakh Only) below which the said Secured Asset as mentioned in Annexure "A" will not be sold and which sale will be on "as is where is basis & as is what is basis and whatever is basis".
6. This is to inform you all, that all the requisitions under the provisions of SARFAESI Act and The Security Interest (Enforcement) Rules, 2002 have been complied with and KMBL now proposes to sell the secured asset as mentioned in **Annexure "A"** annexed herewith by public auction and/or any other methods as prescribed under the provisions of Rule 8 (5) of Security Interest (Enforcement) Rules, 2002 read with proviso to Rule 9 Clause (1) after a period of 15 days from the date of this notice **along with the existing encumbrances if any ' as is where is basis & As is what is basis & Whatever there is basis'** , unless we receive the entire outstanding amount i.e. Rs. 40,53,625.67/- (Rupees Forty Lakh Fifty Three Thousand Six Hundred Twenty Five And Sixty Seven Paise Only) as on 01.03.2024 along with future interest applicable from 02.03.2024 until payment in full and other charges as demanded in our notice, within the statutory period of 15 (FIFTEEN) days, from the date of present notice and please take notice that if in case auction scheduled herein fails for any reason whatsoever then secured creditor may enforce security interest by way of sale through private treaty.
