





# State govt sees scope for more check-dams on big streams

In order to utilise every drop of water available in the State, the Telangana government has decided to emulate the model of Karnataka and Maharashtra to construct a large number of check-dams across the State. And the Irrigation Department too started their efforts in right earnest towards achieving that objective.

der the directions of Chief Minister K Chandrasekhar Rao, a committee headed by retired chief engineer Vijay Prakash carried out a study on the construction of check-dams on streams and rivulets. On Monday, Vijay Prakash conducted a workshop for minor irrigation engineers at Jala Soudha on how to construct check-dams and how to identify the ideal locations for such dams.



ing Agency (NRSA) maps, Vijay Prakash explained that they divided the rivulets into eight categories in the State. Priority for the construction of check-

dams would be given to rivulets nearer to project command areas.

Prakash said that he has identified as many as 319 check-dams, anicuts and other rain water harvesting structures in Godavari basin, covering 6,500 km and another 466 structures were identified in Krishna basin covering 5,700 km in the State. "However, all these structures are on small streams. There is a scope for constructing more check-dams on big

streams," he said, while suggesting the officials to go in for "handshake" type check-dams so that all of them would be integrated. He suggested not to propose the construction of check-dams where the groundwater is available at three-metre depth.

The villages where the groundwater is over exploited would be given preference in constructing the check-dams, Groundwater Department Director Pandit suggested.

# Industry-friendly curricula for UG students mooted

Dept of Collegiate & Technical Education would add MOOCs to syllabus with 20 per cent credits

In a bid to make undergraduate education more flexible and industry oriented, collegiate education is set to get a facelift in the 2020-2021 academic year. This is due now that the engineering and polytechnic colleges have gotten a make over recently.

The Department of Collegiate and Technical Education of Telangana has decided to incorporate Massive Online Open Courses in the curriculum with 20 per cent credits for the same, said Navin Mittal, commissioner of Technical Education. He was speaking to Express during the 9th Higher Education and Human Resource Conclave organised by the Department of Collegiate and Technical Education of Telangana along with Telangana State Council of Higher Education on Monday.

"The collegiate education is in the midst of a change. We have already brought in some curriculum framework which is more flexible. From the next academic session, 20 per cent credits will be obtained through MOOCs. There will also be an option for cross disciplinary programs and focus

will be on project-based learning in the final year," said the commissioner, adding that the curriculum is being revised with respect to market needs. Skills that are generally understood as co-curricular or extra-curricular, such as computer, communication skills or managerial skills, will now be brought within the framework of the curriculum.

The department has also proposed to divide major subjects into 4 buckets, of which three would have to be chosen by students. Within each bucket, there will be multiple options. Students from the science stream will have the option to study Economics/ Computer/ Statistics with the Maths, Physics, Chemistry combo.

# KTR inspects KLIS works in Konaraopet

TRS working president and Sircilla MLA KT Rama Rao on Monday inspected the ongoing works on the Malkapeta tunnel in Konaraopet mandal, which is part of package-9 of the Kaleshwaram Lift Irrigation Scheme (KLIS). Rao praised

concerned engineers and compared their work to that of Chinese engineers. "Engineers in Telangana are creating engineering marvels like those in China. I am sure the Kaleshwaram project will fulfil the dreams of thousands of farmers," he said. He said that 90 per cent of work in Malkapet reservoir was complete

and only some distributor channels were yet to be built. Rao added adding that water would be supplied for irrigation by October.

KLIS was envisioned to provide irrigation water to over 2 lakh acres in the district. "We want to ensure farmers have sufficient water to grow crops during both seasons," he said.

# TS to share cost of laying rail line to Jaggaiahpet

THE State government has in principle agreed to bear its share of the cost for conducting the survey and also for the construction of a 115-km long railway line from Bibinagar in Telangana to Jaggaiahpet in Andhra Pradesh.

TRS leader and Rajya Sabha member Badugula Lingaiah Yadav submitted a

memorandum to Chief Secretary SK Joshi at Secretariat on Monday requesting the State government's consent for the laying of the railway line.

Lingaiah Yadav raised the issue in Rajya Sabha and also took up the matter with Railway Minister Piyush Goyal. Railway Ministry wanted the MP to get a letter from the State indicating that it would bear its share of the cost.

# 'Students detained in US are not being tortured'

CONTRARY to allegations that the Indian students, who have been arrested in connection with the enrolment in the fake University of Farmington after an undercover operation, are being physically tortured and packed into a single cell, local Telugu organisations across the US said this was not true. Calling the allegations baseless, they said that the students are being taken care of properly.

In addition to providing legal aid, the groups have also visited the detained students and said that though they are placed in detention centres, there is no possibility of anyone being roughed up. "They are placed in detention centres along with criminals so naturally there will be anxiety among students. There was an allegation that a female student was given beef but that because they do not have exclusive vegetarian food. But I am sure they will have some vegetarian food too. It is a detention centre so

it cannot be conformable. And this was a stray incident," said Mohan Nannapaneni, founder of Team Aid.

Different associations like Team Aid, TRS unit of USA and American Telugu Association among others have had members visit the detention centre and are trying to attach one attorney with each centre. With students scattered across different jails and detention centres across the US, associations said it is difficult to get hire lawyers when fee can be as high as \$2,000.

Associations have also lauded the Indian External Affairs Ministry for handling the matter sensitively. With the Indian Embassy getting Consular access, diplomats and attorneys are able to meet the students. "Attorneys are trying to end settle the matter before the matter goes to trial," said Nannapaneni.

The eight recruiters, who are being put for trial by the US ICE for facilitating the 600 students' illegal stay in the US will be produced before the US Criminal court on Monday.

"However there is no clarity as to the number of students who have returned so far. Students definitely are returning everyday. We estimate hundreds of them must have returned in the past few days," Mohan Nannapaneni said.

Those who have returned, meanwhile, are still apprehensive to reveal their identity, speak publicly or even use their US phone numbers. A student Express spoke to who was one of the first ones to return said that he has lost everything.

"Not only have I lost the money I had paid, I have lost my job there and for the next three years I can't even go back to the US. The 'deported' stamp on the passports will have repercussions all through our lives," he rued.

**HC reserves order on petitions against panchayats' merger into municipalities**

A division bench of Telangana High Court on Monday reserved its orders in batch petitions filed challenging merger of various gram panchayats into municipalities in various districts of the State.

The bench comprising Chief Justice TBN Radhakrishnan and Justice A Rajashekar Reddy was dealing with petitions filed challenging Section 3(a) of the Telangana Municipal

Senior counsels Vedula Venkataramana and Sarasani Satyam Reddy, appearing for the petitioners, contended that the State government was acting as per its whims and fancies in merging gram panchayats into municipalities which was nothing but depriving the rights of the poor villagers.

After hearing both sides, the bench reserved its orders on the issue.
