Student union polls can't be held in Sept as prescribed in academic calendar

Amidst confusion over format of student union polls, what is clear is that elections will not be held in September as mentioned in academic calendar 2019-20.

And here the violator of calendar would be none other than the government that prepared it and directed all varsities to adhere to it strictly.

As per the calendar, the student unions should be formed by August or September.

While August passed in admissions, September will see government thinking on format of elections (direct or indirect).

While higher education minister Jitu Patwari has openly said many a time that he is for direct elections, police may suggest otherwise to chief minister Kamal Nath as maintaining law and order would become a big challenge for them if elections were held in direct mode.

However, no matter in which mode the government decides to hold elections eventually, it is certain that student union cannot be formed by September even if the government issues notification by mid-September.

The government will have to give at least 20 days for

preparations of elections, nomination, withdrawal of nominations and voting arrangements.

GOVTS SHY AWAY FROM ELECTIONS

Whether it's BJP or Congress-led government in the state, it shies away from holding elections in colleges. It becomes a headache for government to ensure free, fair and peaceful elections. Following orders of Supreme Court, the MP government held student union elections in 2011, which were by and large peaceful yet for another five years no elections were held.

In 2017, elections were

held again but this time student union at university level was not constituted. It had pulled steam out of the elections so no incident of violence took place.

Last year again, the student union elections were not held on the pretext of Assembly elections.

NSUI state chief Vipin Wankhede said that the elections should not only be held but they should be held in direct mode. ABVP leader Rohin Rai also advocate for direct elections.

As part of their international immersion programme (IMP), a group of 14 students of Indian Institute of Management Indore visited China to understand business model of neighbouring country.

"The itinerary of the team was designed in such a manner that the participants get a chance to not only understand the business in China, but also the education system, culture and the work pattern across various constituencies," said IIM Indore faculty Prof G Venkat Raman who led the group.

Raman noted that every constituency in China has a different story to tell. The purpose of this tour was to help participants understand the business strategies of different constituencies.

"Keeping this in mind, we visited Chinese city government state owned enterprise in Hangzhou, wherein the group got a chance to understand how the organisation works, what is the work culture and business tactics," he said.

Besides, the team visited a hardware company named Ace Micromatic wherein the group learnt about their strategy and why they're doing business in China. The team got a chance to meet BRICS Bank president KV Kamath who was former chairman of IIM Indore.

Counsellor General of India Anil Rai also shared his take of a diplomat in China. Thereafter, the group met Indians working in senior positions of big corporations in China from different sectors including chemicals, textiles, aviation etc.

This was followed by a video conferencing with the Counsellor General from Guanzhou who shared Government 2025 plan of the country with emphasis on AI, big data, chemical industry and its impact on India and China relations.

The team also visited two top business schools of China namely, School of Entrepreneurship in Shanghai University and the oldest management school of China—Antai School of Economics and Management.
