The sealed bid cover/envelope/s will be opened in the presence of the bidders present at the aforementioned venue/office at **03:00 pm** on the same day i.e. **13th August, 2019**. The Auction / inter se bidding will take place immediately after opening of bids, where the bidders can remain present and revise their offers UPWARDS. The highest bidder is required to deposit 25% of the bidding amount (inclusive of EMD i.e. 10% of the reserve price already deposited with bid) immediately but not later than by next

working day through Demand Draft/Pay Order of a scheduled bank favoring **“Kotak Mahindra Bank Limited - A/c No. 09580159016001, payable at New Delhi** and the balance 75% of the Sale amount within thirty (30) days from the date of Sale Confirmation letter issued by Bank, failing which the Bank shall forfeit the entire amount already paid by the bidder. No interest would be paid by Bank on deposit of EMD or other amounts deposited by the bidders.

Terms and Conditions of Sale:

- (i) Sale will strictly be on **“AS IS WHERE IS BASIS” and “AS IS WHAT IS BASIS” and “WHATEVER THERE IS BASIS”** on the terms and conditions as mentioned herein, however the Authorised Officer shall have the absolute discretionary right to change or vary any of the terms and conditions. The bidders are advised to make their own inquiries regarding any encumbrances, Search in Sub-Registrar Office and Revenue Records and Municipal Records and any administrative Government records relating to the concerned Property and shall satisfy themselves regarding the nature and description of the property, condition, any encumbrances, lien, charge, statutory dues, etc. before submitting the bid for the concerned Property.
- (ii) The particulars of Secured Assets specified in the Schedule hereinabove have been stated to the best of the information of the Authorised Officer, but the Authorised Officer shall not be answerable for any error, misstatement or omission in this proclamation.
- (iii) Bidders need to improve their offer in multiples of Rs.1,00,000/- (Rupees One Lakh) minimum for respective property/ies.
- (iv) The secured asset will not be sold below the reserve price and sale shall be confirmed to the highest bidder. However, the Authorised Officer is not bound to accept the highest bid or any or all bids and reserves the absolute right and discretion to accept or reject any bid without assigning any reason whatsoever. The highest bidder will not have any right and title over the property until the sale is confirmed by the Authorised Officer and Sale Certificate is registered in their favour subject to realisation of entire Auction Price.
