

## PUBLIC NOTICE FOR AUCTION CUM SALE

Notice is hereby given for conducting sale by public auction, pursuant to taking possession of the secured asset mentioned hereunder by the Authorised Officer of Kotak Mahindra Bank Ltd. under the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and rules 8 (6) & 9 of the Security Interest (enforcement) Rules 2002, of the immovable property for the recovery of amount due from borrower/s. Whereas the borrower/s failed to repay the loan amount together with future up to date interest at documented rate & costs to Bank, within sixty days from the date of Demand Notice under Section 13 (2) of the SARFAESI Act, 2002 issued by its Authorised Officer.
