

शीर्ष न्यायालय ने 'बिंदास बोल' कार्यक्रम के संदर्भ में सुदर्शन टीवी से पूछा

क्या मीडिया को पूरे समुदाय को निशाना बनाने का है अनुमति

नई दिल्ली, 18 सितंबर।

उच्चतम न्यायालय ने शुक्रवार को 'बिंदास बोल' कार्यक्रम के संदर्भ में सुदर्शन टीवी से पूछा कि क्या मीडिया को 'पूरे समुदाय को निशाना बनाने की अनुमति दी जा सकती है।' बता दें कि बिंदास बोल कार्यक्रम के प्रोमो में दावा किया गया है कि सरकारी सेवाओं में मुसलमानों की घुसपैठ का बड़ा खुलासा किया जाएगा। शीर्ष अदालत ने कार्यक्रम को लेकर की शिकायत पर सुनवाई करने के दौरान कहा कि चैनल खबर दिखाने को अधिकृत है लेकिन 'पूरे समुदाय की छवि नहीं बिगाड़ सकता और इस तरह के कार्यक्रम कर उन्हें

अलग-थलग नहीं कर सकता। मामले की सुनवाई कर रहे पीठ की अध्यक्षता कर रहे न्यायमूर्ति डी वाई चंद्रचूड़ ने कहा, 'यह वास्तविक मुद्दा है। जब भी आप उन्हें प्रशासनिक सेवा से जुड़ते दिखते हैं, आप आइएस (इस्लामिक स्टेट) को दिखाते हैं। आप कहना चाहते हैं कि प्रशासनिक सेवा से मुसलमानों का जुड़ा गहरी सजिशा का हिस्सा है। क्या मीडिया को एक पूरे समुदाय को निशाना बनाने की अनुमति दी जा सकती है।' पीठ ने कहा, 'सभी उम्मीदवारों को एजंडा के साथ दिखाना नफरत को दिखाता है और यह तत्व चिंता का विषय है।' इस पीठ में न्यायमूर्ति इंदु मल्होत्रा और न्यायमूर्ति केएम लक्ष्मण भी शामिल हैं।

न्यायालय ने कहा, 'यह बोलने की आजादी नफरत

में तब्दील हो गई है। आप समुदाय के सभी सदस्यों की एक छवि नहीं बना सकते हैं। आपने अपने विभाजनकारी एजंडे के जरिए अच्छे सदस्यों को भी अलग-थलग कर दिया।' पीठ ने सुदर्शन टीवी का पक्ष रख रहे श्याम दीवान से कहा कि अदालत को आतंकवाद से जुड़े संगठनों द्वारा वित्तपोषण संबंधी खोजी पत्रकारिता से समस्या नहीं है लेकिन यह नहीं कहा जाना चाहिए कि मुसलिम एजंडे के तहत यूपीएससी सेवा में जा रहे हैं।

पीठ ने कहा, 'मीडिया में संदेश जाना चाहिए कि समुदाय विशेष को निशाना नहीं बनाया जा सकता। हमें बहिष्कार के राष्ट्र को देखना है जो एकजुट और विविधता से युक्त हो।'
