E-AUCTION SALE NOTICE FOR SALE OF IMMOVABLE ASSET OF M/S STRAWBERRY STAR INDIA (P) LTD. UNDER THE PROVISIONS OF THE SECURITISATION AND RECONSTRUCTION OF FINANCIAL ASSETS AND ENFORCEMENT OF SECURITY INTEREST ACT, 2002 (“SARFAESI ACT”) READ WITH PROVISIO TO RULE 8 (6) OF THE SECURITY INTEREST (ENFORCEMENT) RULES, 2002.

Whereas, Kotak Mahindra Bank Limited (“KMBL”) had sanctioned certain credit facilities to **M/s Mauria Udyog Limited** (hereinafter referred to as “Borrower”).

And Whereas, the Authorized Officer of Kotak Mahindra Bank Limited (“KMBL”) had issued notice under the provisions of Section 13(2) of the SARFAESI Act and called upon the Borrowers and the guarantors viz. **M/s Mauria Udyog Limited & Ors** to pay the amounts mentioned therein, within 60 days of receipt of the said notice. The said demand was not complied with. The Authorized Officer took symbolic possession of the properties as detailed herein below, after complying with the provisions of the SARAFESI Act and Rules enacted therein. In exercise of the powers conferred under Section 13(4) of the SARFAESI Act read with the Rules therein, the undersigned has decided to sell the said property by E-auction.

And Whereas notice of sale for a period of thirty days has also been given to the borrower and guarantors on 6th February, 2021. Despite lapse of 30 days, the demand for outstanding dues has not been complied with.

And Whereas Notice is hereby given to the public in general and to the Borrower and the guarantors, in particular that the below described immovable property mortgaged/charged to KMBL, the Symbolic possession of which has been taken by the Authorized Officer of KMBL, will be sold on “**AS IS WHERE IS**”, “**AS IS WHAT IS**” and “**WHATEVER THERE IS**”, by way of E auction to be conducted on **20-May-2021**, for recovery of a sum of **Rs. 14,09,79,731.71 (Rupees Fourteen Crore Nine Lakhs seventy nine thousand seven hundred thirty one and paise seventy one only)** due to KMBL from M/s. Mauria Udyog Limited and its guarantors as on **19/11/2020** together with further interest at the contractual rate **from 20/11/2020 till realization**, together with all incidental costs, charges and expenses.
