Chennai, Oct 21: Vijay's next Nelson Dilipkumar titled 'Beast' has already grabbed the attention of many. Reportedly, Vijay and the team have already completed filming more than 70% of the film. # Inaugural flight to Kushinagar takes off

Sri Lanka, Oct 21: Prime Minister Narendra Modi on Wednesday (Oct 20, 2021) formally inaugurated the International Airport at Kushinagar and to mark this historic occasion an inaugural international flight from Sri Lanka landed at this airport. Sources confirmed to Financial Express Online that diplomats from 12 countries were present during the ceremony. Countries

including Mongolia, Thailand, Lao PDR, Sri Lanka, Bhutan, Republic of Korea, Japan, Nepal, Singapore, Vietnam, and Cambodia, were present. Last June, the Union Cabinet had declared Kushinagar Airport as an International airport. And later in 2020 at the end of a virtual summit between the two countries, 'Mitravta Magga' was mentioned in the joint statement. According to sources, on board

the inaugural flight from Sri Lanka there was a delegation, led by Cabinet Minister Namal Rajapaksa, who is the son of Prime Minister Mahinda Rajapaksa. He is handling several ministerial charges including Youth & Sports, Development Coordination and Monitoring and he is also State Minister of Digital Technology and Enterprise Development.

# SK joins hands with 'Ratsasan' director

Chennai, Oct 21: The hot news in Kollywood is that Sivakartheayan is joining hands with versatile director Ramkumar of 'Mundasupatti' and 'Ratsasan' fame. The film will be produced by Sathyajyothi Thiagarajan and is likely to go on floors in March 2022. The rest of the cast and crew details will be announced soon. Earlier Ramkumar after giving the blockbuster hit 'Ratsasan' signed a fantasy adventure film starring Dhanush for Sathya Jyothi Films. But after more than three years of preproduction there is undue delay in starting the project and hence he has moved on to this new project. Sources say the Dhanush film will takeoff by the end of next year.



# Revised guidelines for international passengers

Chennai, Oct 21: The government has issued revised guidelines for international passengers coming to India. Travellers fully vaccinated and coming from a country with which India has reciprocal arrangements for mutual acceptance of WHO approved COVID-19 vaccines shall be allowed to leave the airport and need not undergo home quarantine and testing from October 25, according to the revised guidelines for international arrivals released on Wednesday. They will, however, have to produce a negative COVID-19 RT-PCR report. If partially or not vaccinated, the travellers need to undertake measures which include submission of sample for post-arrival COVID-19 test at the point of arrival after which they will be allowed to leave the airport, home quarantine for seven days, re-test on the eighth day of arrival in India and if negative, further self monitor their health for next seven days. Travellers coming from these countries who are fully vaccinated and 15 days have elapsed since completion of COVID-19



vaccination schedule, they shall be allowed to leave the airport and shall self monitor their health for 14 days post arrival, according to the revised guidelines. While planning for travel, all travellers should submit self-declaration form on the online Air Suvudha portal before the scheduled travel and upload a negative COVID-19 RT-PCR report. This test should have been conducted within 72 hours prior to undertaking the journey, according to the guidelines. Each passenger shall also submit a declaration with respect to authenticity of the report and will be liable for criminal prosecution, if found otherwise. If traveller is coming from a country excluding those covered under these

category A (coming from a country with which India has reciprocal arrangements for mutual acceptance of WHO approved COVID-19 vaccines,) they would be required to undergo the measures such as submission of sample for post-arrival COVID-19 test at the point of arrival after which they will be allowed to leave the airport, home quarantine for seven days, re-test on the eighth day of arrival in India and if negative, further self monitor of their health for next seven days, irrespective of their COVID-19 vaccination status.



# Samantha files case against YouTube channels

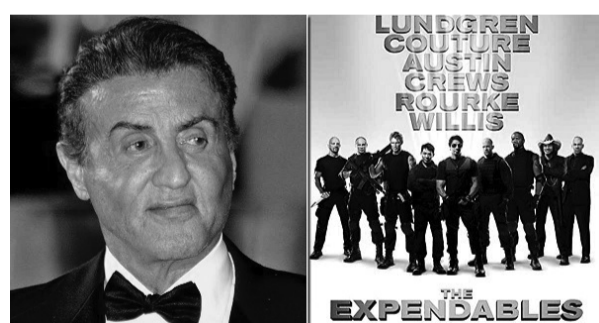
