

AIRPORT CARGO STAFFER HELPS GOLD SMUGGLERS, ARRESTED

Woman collected consignment from a couple who arrived from Dubai

IN a shocking turn of events, the staffer of a cargo handling unit at the Kempegowda International Airport was caught red-handed on Wednesday morning, abetting a woman flyer from Dubai in smuggling gold. Women staffers of the Air Intelligence Unit of Airport Customs had to don burqas and hang around in the ladies restroom to intercept the suspects and foil their smuggling bid.

The gold smuggled in a plastic sheet weighed 1 kg, while the final quantity after extraction was 880 grams. The 22-year-old staffer is an employee of AISATS, a joint venture between Air India Limited and SATS Limited, a gateway service provider for Asia, said a top Customs official.

According to the official, the team was tipped off about gold being smug-

gled by a passenger on an arriving Emirates flight. "When the specific flight, EK 564, arrived, we monitored the passengers closely. When conducting checks at the immigration area, our staffers found a couple repeatedly visiting toilets nearby," the official explained.

Two Customs staffers donned burqas and entered the ladies toilet. "Our team was waiting around when they found the staffer of a cargo handling company enter a cubicle next to the one that the suspected woman smuggler had entered. In the open space beneath the two cubicles, the flyer passed on a plastic sheet containing gold in paste form to the staffer. They understood this to be the exchange of gold," the official explained.

As soon as the staffer left the toilet, she was subjected to physical checks and the package was recovered from her person. The couple was also held. Another team nabbed two men outside the terminal, who were waiting for the consignment to be delivered.

Three held for hacking Bidari's email account

BENGALURU: South-East division police arrested three suspects, including a woman, for allegedly hacking the email account of former DG&IGP Shankar Bidari and doing away with Rs 25,000. The accused, identified as Thia Rit Samong (31), Seropa Sesai (27), and Ester Konyak (28), hail from Nagaland, and have been residing in Horamavu since a few years. A week ago, Bidari found that his email account had been hacked. He contacted cyber crime police, who tracked down the three, who are part of a five-member gang, who had allegedly hacked Bidari's account and sent an SOS mail to all his contacts, seeking help of Rs 25,000. Fracas over delay: Food delivery boy punches customer, held

ELECTRONICS City police on Wednesday arrested a 27-year-old delivery boy working for Zomato, who allegedly barged into a woman's house and assaulted her. The arrested was identified as Kamaraj, a native of Tamil Nadu.

Police said the complainant, Hitesha Chandranee, filed a written complaint on Wednesday. Based on her allegations, Kamaraj was arrested and remanded in judicial custody. During interrogation, Kamaraj told police that he and Hitesha had an argument, and the woman made him to wait a long time as she wanted free food. She also provoked him, he claimed.

Hitesha, who claims she is a content creator and make-up artist, posted the

incident on social media, alleging she was assaulted on March 9. Hitesha, seen with a bloody gash on her nose, alleged that the delivery boy attacked her after she confronted him over delay in the delivery of her order. She further alleged that the delivery executive barged into her home to take back the order, as she forced him to wait for more than a hour.

Meanwhile, a Zomato spokesperson stated in a release: "We deeply regret this incident and apologise to Hitesha for this traumatic experience. We are in touch with her and are providing our complete support through necessary medical care and investigation. Meanwhile, we have delisted the delivery partner from our platform."
