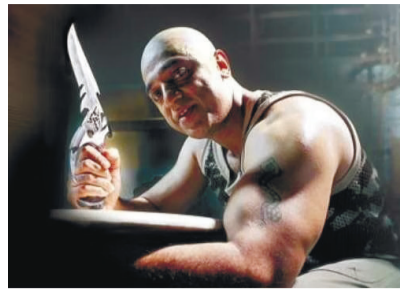


# Kamal's 'Aalavandhan' to re-release soon

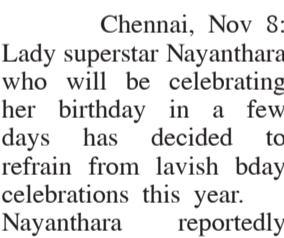


Now, reports are that the film's shooting has resumed today. Actress Aditi Shankar, who made her debut with Karthi-starrer
