Bhutan charges Rs.1200 per Indian tourist

Bhutan, Sept 24: Bhutan has finally opened its doors for international tourists after shutting its doors to international tourists for two and a half years during the Covid pandemic.

The reopening has come with a revised tourism levy, called the Sustainable Development Fee.

Bhutan raised its Sustainable Development Fee to \$200 per visitor

per night from the \$65 it had been charging foreign tourists for the last three decades.

Indians were not charged anything before the pandemic began, but rules specify that they now have to pay a sum of Rs1200. However, the revised fee for Indian tourists was never implemented.

In March 2020, Bhutan shut its borders to visitors - a major source of income - after

detecting its first case of COVID-19.

The Himalayan Kingdom of fewer than 800,000 people has reported a little over 61,000 infections and only 21 deaths, but its economy has suffered in the last two years, causing a spike in poverty.

"The Government of Bhutan has re-strategized its 'High Value, Low Volume' tourism policy to ensure the sustainable

use of tourism resources and to create an enabling environment for a vibrant, non-discriminatory, inclusive, and high-value tourism industry in Bhutan," said Jigme Thinley Namgyal, Bhutan's Consul General to NDTV.

Bhutan, wedged between India and China and famous for measuring gross national happiness, hopes to welcome more tourists who can spend money.



Thailand removes all entry requirements

Thailand, Sept 24: Thailand has become the latest destination around the world to remove all of its Covid-19-related entry requirements and return to normal tourism.

The Land of Smiles - one of the most popular destinations in the world for travelers prior to the pandemic - has struggled throughout most of the past three years from a tourism point of view due to strict and unrealistic entry requirements,

but will be hoping to welcome a significant number of tourists back once these changes to their entry requirements go into effect.

With visiting Thailand now set to be more attractive than ever thanks to longer visas on arrival being offered at present and beaches far less crowded than they once were, the country has well and truly been put back on the map for millions of travelers

around the world. Here's a look at what changes are set to take place, when they'll be active and why travelers keep coming back to this Southeast Asian gem.

Prior to the pandemic, Thailand was one of the most popular places to visit on the planet. Bangkok, the country's sprawling capital, was crowned the world's most visited city, attracting all kinds of travelers from a diverse range of countries. Yet whilst Covid-19 may have put a serious dent in the number of travelers flocking to the country, the decision to remove all of the country's Covid-19 related entry

requirements could see travelers returning in their millions over the next few years.

Following a meeting with the National Communicable Diseases Committee (NCDC) on Wednesday, Thailand's Public Health Minister Anutin Charnvirakul revealed yesterday that the country would be removing the Covid-19 related restrictions on international arrivals that had been put into place over the past few years, making entry into the country just as easy as it was before the pandemic threw the travel-sphere of a curveball of a lifetime.

Ras Al Khaimah turns IndiGo's 100th destination

Chennai, Sept 24: Indian budget carrier IndiGo marked its 100th destination to its flight roster with daily flights to Ras Al Khaimah from Mumbai. With this, IndiGo now flies to 26 international destinations and 74 domestic.

Speaking to the media after the inaugural flight, Pieter Elbers, newly-named CEO of the airline, noted that the flight was at nearly full capacity and interestingly carried passengers not just from Mumbai but from multiple locations across the country. "I may be just three weeks into this job, but I'm really excited about the journey ahead for IndiGo. With Ras Al Khaimah, we now fly to all six of the GCC countries," he stated, noting that the UAE is important to the carrier, given that it operates approximately



160 flights between India and the UAE. The airline also recently added a few more destinations, including Bahrain.

Elbers emphasised the company's focus on growing its international travel business. It has over the past few years forged partnerships with Turkish Airlines, Qatar Airways, Air France, KLM and most recently, Virgin Atlantic. "These ties partnerships are beneficial not only to our partners but also to IndiGo. With the kind of foundation we have in both our domestic and international business, we are optimistic about our growth too, especially with the pandemic behind us.
