Ten-day package to explore Durga puja festival

West Bengal, Sep 1: The government of West Bengal is bringing a ten-day package to explore its Durga puja festival.

The West Bengal government has formed seven panels, headed by experts in the hospitality sector, to chart a road map for tourism development in the state — from the hills to the seas — minister Babul Supriyo said. Supriyo, during a programme of Hotel and Restaurant Association of Eastern India here, also said

that one of the panels will soon come up with ways Durga puja can be showcased everywhere, a festival that is "no less spectacular and inclusive than the carnival in Rio".

"We will initiate projects involving both public and private sectors to make Bengal, which is blessed with hills, seas and jungles, a one-stop destination for tourists. We will also meticulously plan tourism circuits along rivers," Supriyo stated on Tuesday.

The panels, after a series of brainstorming sessions, will share their plans and ideas by end-September; the state tourism minister said. "A ten-day package to explore the Durga puja festival, its different sides, will be made available to the visitors. We are also weighting the option of starting a 15-day Gangasagar package, as part of which tourists can board a cruise from Babughat, touch different ghats, and reach Sagar Islands.

'Natchathiram Nagargirathu' discusses politics behind love

Pa Ranjith's 'Natchathiram Nagargirathu' shows how caste, class, gender and sexuality are used to protect endogamy in romance. He is one of the most important voices in exploring the socio-political movement in Tamil cinema
Dushara, Kalai and Kalidas play theatre actors with a small troupe. The film sets off with the troupe trying to decide what their next play is going to be about.
Discussions turn to each of their interpretations of love and desire, and very soon, conflict



slips in. Here is where the director seems to indulge in a little bit of clever wordplay. Kalai's character Arjunan comes from a dominant land-holding caste. He starts passing snide remarks about "naadaga kaathal" (loosely translated as drama-love, or fake love), a prejudiced narrative used in Tamil Nadu against Dalit men who dress stylishly in jeans

and sunglasses to allegedly "lure upper-caste women." The film openly and unabashedly discusses 'naadaga kadhala', which is Dalits' version of love jihad. As it tries to dissect naadaga kadhala, Ranjith smartly stays away from shoving the blame on any particular community. Instead, he uses it as a topic of discourse between his

actors, who come from different communities and follow different ideologies. In one of the best scenes of the film, all the actors sit down to talk about love and their understanding of it. While some argue that love is a universal feeling, others ask why can't two people continue to be in love without getting married. Some talk about genderless love and why only people of the opposite sex have the freedom to be in love and marry.
No filmmaker has so bravely discussed the politics behind love, and Ranjith has no qualms in asking all the uncomfortable questions which includes reasons behind honour killings.

'Cobra' Vikram delivers worthy performance

With the help of a criminology student from Chennai, Aslan finds out that a criminal named Cobra is responsible for all the assassinations, but his identity remains a mystery. Aslan travels to Chennai to work with the local police to nab the killer.
Vikram plays Mathiazhagan, a genius mathematician who lives the life of a recluse.



Aslan's investigation reveals that Cobra could also be a mathematics genius and suddenly all the clues point fingers towards Mathi, who gets involved in the case. Is Mathi really Cobra? And if yes, why is he on a killing spree? This forms the crux of the plot.
Vikram, who shoulders the film all the way.

Vikram has always been doing roles which are quite complex. The same happens here with Cobra as well. He gets a role with dual shades and performs it beautifully. All the hallucination scenes performed by the star hero are top notch. Srinidhi Shetty gets a good role and does her bit in the first half. Irfan

Pathan makes a decent debut and is neat as a cop. Muralini Ravi gets a neat role in the flashback and she was good. Roshan Mathews gets a negative role and he is impressive. Vikram's performance is top notch and AR Rahman's music is an asset for the film.

Heliports to boost tourism in unexplored areas of HP



The one-way fare per passenger is Rs.3,275, he added. Jai Ram said that his government had recently sent a proposal to extend the helicopter services to Reckong Peo and Chamba.

Himachal Pradesh, Sep 1: The Chief Minister of Himachal Pradesh Jai Ram Thakur on Tuesday inaugurated a heliport built at a cost of Rs.3.4 crore at Rampur in Shimla district.

He said that the government has taken several initiatives to attract tourists to the unexplored areas and was working to develop a network of heliports to improve air connectivity in the state. The work at Shimla heliport near Sanjauli

bypass road, Baddi in Solan district and Rampur have already been completed under UDAN (Ude Desh Ka Aam Nagrik) scheme, he said. The helicopter service operations will get started at these three sites soon, he added. Meanwhile, the heliport at Kangnidhar in Mandi was near completion and another is being developed at Manali (DGRE, SASE), Jai Ram said.
The CM said the heli-taxi services on Shimla- Rampur-Shimla route were started in December 2021 and

flights were operating thrice a week.
