


'Mahaan' to stream on Prime Video next month

'Jai Bhim' bags three back to back awards



Chennai, Jan 25: Jai Bhim has bagged three main awards at the 9th Noida International Film Festival and the official announcement was made today. The film features Suriya, Lijamol Jose and Manikandan in lead roles. Not long ago, 'Jai Bhim' was featured on the official YouTube channel of the Oscar Awards and it was shortlisted as one of the eligible films for the 94th Academy Awards. Earlier, the movie was also nominated for the Golden Globe Awards

2022 for the Best Non-English Language Film. The movie was directed by T.J Gnanavel and the movie had Suriya, Lijamol Jose and Manikandan in the lead roles. Lijamol Jose plays the role of Sengani, whose husband Raja Kannu (portrayed by Manikandan) gets arrested by the police for a crime that he has not committed. Sengani and Raja Kannu belong to the Irular tribe and the movie portrays the injustice happening to the tribal people because of caste politics. Sengani who is pregnant and with the help of a lawyer Chandru (portrayed by Suriya) tries to find out the truth about her husband who goes missing while under police custody. It is later found out that Raja Kannu has been harassed by the police and dies while in custody but the police states that he ran away from the police station and went missing. Later, the movie shows how the lawyer tries to fight injustice against the tribal people to get them their basic living rights.



AI to check cabin crew's grooming, BMI

New Delhi, Jan 25: Air India has decided to check grooming and measure the body mass index (BMI) of cabin crew members at the airports just before their flights, according to an official order. The carrier's two unions - Air India Employees' Union (AIEU) and All India Cabin Crew Association (AICCA) - on Monday wrote a letter to Chairman and Managing Director (CMD) Vikram Dev Dutt opposing the order on the grounds that it is dehumanising and in violation of rules prescribed by aviation regulator DGCA. "BMI is a person's weight in kilograms divided by the square of height in metres. A high BMI can indicate high body fatness," stated the website of US' Centers for Disease Control and Prevention. The order dated January 20, 2022, has come days before Air India's hand over to the Tata group, which acquired the carrier in a competitive bidding process last year. Cabin crew, who are well dressed and well groomed according to uniform standards and regulations, present a positive and professional image of the airline, the order stated. "It is therefore emphasized that, all cabin crew adhere to uniform regulations communicated by the circular dated November 18, 2019," the order noted. The January 20 order was sent by Vasudha Chandana, Executive Director - In-flight Services, Air India, to all cabin crew members in the carrier.



UK scraps COVID tests for fully vaccinated

London, Jan 25: Britain on Monday announced that it will scrap COVID-19 test requirements for fully vaccinated travellers entering England from next month. UK Transport Secretary Grant Shapps made a statement in the House of Commons outlining the COVID travel update, confirming that from 4am local time on February 11 travellers who have had both doses of a COVID vaccine will no longer be required to take a test within two days of arriving in England. "We are removing all testing measures for eligible fully vaccinated arrivals to England from 4am on February 11, said Shapps. "These changes have been made possible by the success of our vaccine and booster rollout. Arrivals in England who aren't fully vaccinated will only need to take a pre-departure test and a PCR test on or before day two after arriving in England. All passengers will still need to complete a Passenger Locator Form, he said. Shapps clarified that "fully vaccinated" means two doses of an approved vaccination, including those administered in India, or one dose of a Janssen vaccine. "That means that after months of pre-departure testing, post-arrival testing, self-isolation, additional expense, all that fully vaccinated people will now have to do, when they travel to the UK, is to verify their status via a Passenger Locator Form," Shapps told the House of Commons.

Did you know?? Penicillin was first called 'mold juice'



In 1928, bacteriologist Alexander Fleming started to research common staphylococcal bacteria. He left a petri dish in his lab while he was on vacation—only to return and find that some liquid around the mold had killed the bacteria in the dish. He isolated the mold and identified it as Penicillium genus, which he found to be effective against all Gram-positive pathogens. Gram-positive pathogens cause diseases, such as diphtheria, gonorrhoea, meningitis, pneumonia, and scarlet fever. Fleming discovered that it was not the mold itself but a "juice" it had produced that had destroyed the bacteria. He named this "mold juice" penicillin. Later, Fleming said: "When I woke up just after dawn on September 28, 1928, I certainly didn't plan to revolutionize all medicine by discovering the world's first antibiotic, or bacteria killer. But I suppose that was exactly what I did." Initially, the medical community was not so enthusiastic about Fleming's penicillin discovery. He also had difficulty isolating large quantities of "mold juice." In 1940, just as Fleming was about to retire, 2 fellow scientists, Ernst Chain and Howard Florey, became interested in penicillin. Soon, they were able to mass produce penicillin for use during World War II.

Riya Suman plays Santhanam's assistant in 'Agent Kannayiram'

Chennai, Jan 25: Actress Riya Suman, who kick-started her journey in the Tamil industry with Jiiva starrer Seeru is currently working on Santhanam's Agent Kannayiram and an other project with Director Venkat Prabhu for his film Manmadha Leelai. She is excited to be a part of these two projects that have offered her more scope to exhibit her potential. The actress states, when Manoj Beedha approached her for Agent Kannayiram, the adaptation of the Telugu movie Agent Srivastava, he didn't want her to watch the original version as it would influence her. Significantly, Riya feels that her role has no resemblance with the original, except the character description of being an assistant to the detective that she found while watching it after almost completing the shooting. The pretty actress acclaims Santhanam for his down-to-earth and humble nature. Besides, she feels that spirituality was the common factor between them. Riya Suman adds that the story of Manmadha Leelai is set in two different time zones - Past and Present, and she appears in the latter one. Riya signs off saying that she has already signed a couple of Telugu projects, and a few more Tamil projects are in the pipeline that will keep her busy for the entire year.
