Report of Scrutinizer

I, P. N. Parikh, Partner of M/s Parikh & Associates, Practising Company Secretaries (Membership No. FCS 327), having my office at 111, 11th Floor, Sai Dwar CHS Ltd., Sab TV Lane, Opp. Laxmi Industrial Estate, Off Link Road, Andheri (West), Mumbai - 400053, have been appointed as the Scrutinizer to scrutinize the evoting process for the Postal Ballot through electronic voting ("remote e-voting") conducted by Kotak Mahindra Bank Limited ("**Bank**") in respect of the following Resolutions:

pursuant to the Postal Ballot Notice dated February 10, 2024, issued under Section 110, 108 and other applicable provisions, if any, of the Companies Act, 2013 (the "**Act**") (including any statutory modification or re-enactment thereof for the time being in force) read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 (the "**Rules**"), as amended from time to time, read with the General Circular No. 14/ 2020 dated April 8, 2020 and the General Circular No. 17/ 2020 dated April 13, 2020, and the subsequent circulars issued in this regard the latest being Circular No. 9/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ("**MCA**") (hereinafter collectively referred to as "**MCA Circulars**"), Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("**SEBI LODR Regulations, 2015**") and other applicable laws and regulations.

The Postal Ballot Notice dated February 10, 2024 along with explanatory statement setting out material facts under Section 102 of the Act in respect of the above mentioned Ordinary and Special resolutions, as confirmed by the Bank, was sent in electronic form to those Members whose e-mail address was registered with the Bank/Depositories/Registrar and Transfer Agent and whose names were recorded in the Register of Members of the Bank or in the Register of Beneficial Owners maintained by the Depositories as on Thursday, February 8, 2024 ("**Cut-off date**").

The Bank had availed the e-voting facility offered by National Securities Depository Limited ("NSDL") for conducting remote e-voting by the Members of the Bank.

The Members of the Bank holding shares as on the Cut-off date were entitled to vote on the resolutions as contained in the Notice.

The voting period for remote e-voting commenced on Monday, February 12, 2024 (9:00 a.m. IST) and ended on Tuesday, March 12, 2024 (5:00 p.m. IST). The e-voting module was disabled by NSDL thereafter.

The votes cast under remote e-voting facility were thereafter unblocked.

I have scrutinized and reviewed the votes cast through remote e-voting based on the data downloaded from the e-voting system of NSDL and have maintained a register in which necessary entries have been made in accordance with the Companies (Management and Administration) Rules, 2014, as amended.

The Bank is responsible to ensure compliance with the requirements of the Act, Rules made thereunder and the MCA Circulars relating to remote e-voting on the resolutions contained in the Postal Ballot Notice.

The communication of the assent or dissent of the Member had taken place through remote e-voting only. My responsibility as scrutinizer is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolutions.

I would like to mention that the voting rights of Members were in proportion to their equity shareholding in the Bank as on the Cut-off date i.e. Thursday, February 8, 2024.

Further, I would also like to mention that Shareholders who have split their votes into "Assent" as well as "Dissent" in respect of each DP ID/Client ID or Folio No., while their votes are taken as cast, they have been counted only once for the purpose of their presence, which has been mentioned under the head "Assent".
